The Saskatchewan Ministry of the Economy (ECON) has confirmed that your company is a valid license holder in 2018 with at least one or more wells within the Area 3 Environmental Response Unit (Area 3 ERU) boundaries. Please see attached invoice for the 2018 Area 3 ERU membership fees. Return with your payment (GST not required) to the above noted address by April 30, 2018 and forward this letter to your local operations manager and safety compliance officer for review. If the billing and company information is incorrect, please e-mail the correct information to [area3eru@sasktel.net](mailto:area3eru@sasktel.net) and we will update our records. The member companies and their contact information are also listed on our web site at [www.area3eru.com](http://www.area3eru.com).

ECON requires that the licensee of the facility is a member in good standing with the local spill response unit. *NOTE:* To be a member in good standing you must attend the spill exercise and pay your membership fee. If the licensee fails to uphold their membership, any facilities licensed to them can be suspended for noncompliance under the license conditions. As well, under Section 2.3 of the Saskatchewan Upstream Petroleum Industry Storage Standards, S-01, all operators must maintain their membership with the area spill response unit and participate in the annual training exercise. The annual training exercise is to be held this coming September 12, 2018. Details of the exercise will be posted on the Area 3 ERU web page as they are finalized.

The Area 3 ERU mandate is to provide expertise towards communication, training and contingency planning to minimize risks and environmental damage in the event of a major oil spill. The Area 3 ERU has two fully equipped trailers ready for emergency response to all companies who are members in good standing and located within the Area 3 ERU boundaries (see area boundaries on home page of web site: [www.area3eru.com](http://www.area3eru.com)). One trailer is stored at Fauser Energy Inc. (306.297.3884) located on Hwy 37 by Shaunavon, Saskatchewan and the second trailer is stored at Dynamic Heavy Haul in Gull Lake, Saskatchewan.

Your membership entitles you to the use of the trailers and the equipment contained within for a period of 1 week following deployment. Equipment cleaning, replacement of supplies, and use of the equipment for a period longer than 1 week will be billed at an additional cost.

As part of your membership, the Area 3 ERU provides an annual Control Point Tour and an annual training exercise. The annual Control Point Tour is scheduled for June 7, 2018 at 7 A.M. Please RSVP to [area3eru@sasktel.net](mailto:area3eru@sasktel.net) for further information and meeting location.
